



INCOME RELATED ANNUAL PASS APPLICATION

SECTION A: GENERAL INFORMATION

To be eligible for the INCOME RELATED ANNUAL PASS, you must:

- live in Lambton Shores, South Huron, Bluewater, Plympton-Wyoming or Kettle & Stony Point First Nation
- be 20-64 years old
- have a "Blue Card" from a Lambton County Food Bank, or
- be registered with a Huron County Food Bank, or
- live in social housing, or
- provide a scan of one of the following:
 - Ontario Works (OW) Program identification number
 - Ontario Disability Support Program (ODSP) card or deposit stub

CHECKLIST OF ID REQUIRED

- ☐ Prove residency with government-issued ID or utility bill
- ☐ Birth Certificate
- ☐ "Blue Card" from Food Bank
- ☐ Name of Food Bank
- ☐ Letter from Social Housing verifying tenancy
- ☐ Ontario Works Program ID number
- ☐ Ontario ODSP card

Once your information has been verified and you are approved, the Income Related Annual Pass gives you a 95% discount off the regular fare. You pay 5% or \$84 for unlimited travel for a full year. After one year, requalification is required.

You must purchase the pass through the Transit Coordinator by phone (519-243-1400 ext. 8108) or in person at the Municipality of Lambton Shores office at 9577 Port Franks Road, Thedford, Monday to Friday, 8:30 am to 4:30 pm. Payment can be made by debit/credit, credit card and in cash when paying in person. Bring photo ID with you at time of purchase.

Restrictions

- Funding availability is on a first-come, first-served basis.
- International students, full-time post-secondary students and foreign workers are not eligible.
- Passes are for use by the registered passenger and cannot be sold, transferred, traded, or shared with anyone else.
- Approvals are determined by HSAT and are subject to local demands and budgets.
- If you already receive support for transportation costs from ODSP, you are not eligible for the Income Related Annual Pass.
